Applications are invited from the eligible temporary employees working as **Junior Engineer (Civil)** in various departments on ad-hoc/Contract basis for filling up of 104 (one hundred and four) posts of **Junior Engineer (Civil)** in temporary regular establishment in PB-2 of Rs. 9300-34800 plus grade pay of Rs.3800/- under Roads & Bridges Department, Government of Sikkim, in accordance with the Sikkim State Direct Recruitment (Special Provisions) Rules, 2008 vide Notification No. 137/GEN/DOP dated: 08.07.2008 read with Notification No. 89/GEN/DOP dated: 28.04.2016.

CONDITIONS OF ELIGIBILITY.

- 1. Minimum Educational Qualification:
- (i) Diploma in Civil Engineering (LCE) from a recognized Engineering Institution or equivalent.
- 2. Other requisites
- (a) Candidates who are working as Junior Engineer (Civil) on temporary employees as Ad-hoc & Contract basis under various Department, Govt. of Sikkim.
- (b) The candidate should possess the following documents while applying for the post.
 - (i) Order of appointment,
 - (ii) Joining Report duly certified by concerned HOD.
- (c) Category certificate issued by Competent Authority.
- (d) Candidate must be in possession of either Sikkim Subject Certificate or Identification Certificate issued by the Competent Authority under relevant orders of the State Government.
- (e) Should have knowledge of any of the State Language viz. Nepali/Sikkimese/Bhutia/Lepcha/Limboo.
- (f) Should have valid Local Employment Card.
- (g) Should be conversant with the customs and usages of Sikkim.
- **3.** Duties of the post : To deal with the Civil Engineering Works in the State of Sikkim.

5. All applicants are advised to ensure that all required documents are to be submitted to the Commission in person latest by 5th Sept.'2016.

6. Those candidates who have already applied for the post of J.E. (Civil) in the Sikkim Public Service Commission as per our earlier advertisement No. 15/SPSC/2015 dated: 21.03.2015, need not apply again. However, they should submit all relevant documents and should confirm if their names are listed with Sikkim Public Service Commission.

The candidates who have not applied earlier may **download Application form** from <u>www.spscskm.gov.in</u> The form should be filled up by the candidate himself/herself and submit to the office of the Sikkim Public Service Commission on any working day between 10:30 a.m. to 03:00 p.m. on production of original Bank Receipt of State Bank of Sikkim, for **Rs. 150**/- credited to '**0051-SPSC'**. The amount so deposited shall not be refunded or adjusted against any other purpose.

Last date for submission of filled-in application form is **05.09.2016**

8. Complete application form should be accompanied by (1) attested copies of Class X Mark sheets/Certificate containing Date of Birth. (2) Diploma Mark Sheet/ Diploma Certificate awarded by the Board/University (3) Valid Local Employment Card issued by the appropriate authority of the Government of Sikkim, (4) Certificate of Identification/Sikkim Subject Certificate (5) Category Certificate (6) Marital status (for

female candidates and **(7)** No Objection Certificate from the Appointing Authority/ Head of Department. The application should reach the Secretary, Sikkim Public Service Commission, Old Tourism Office, M.G.Marg, Gangtok by hand or by post on or before **05.09.2016.**

No application forms submitted after **03:00 p.m. on** <u>**05.09.2016</u>** *will be accepted*. SPSC will not be responsible for late receipt of application due to postal delay or otherwise.</u>

9. One (1) stamp size photograph should be affixed in the application form in the space provided and two (2) *identical stamp size photographs* with the candidates name on the back side of the photograph should be submitted along with the application form.

10. Before filling the application form candidate should go through the advertisement and accordingly they should fill the forms. The candidates claiming reservation should categorically specify the categories for which he/she belongs in the box provided in the application form.

11. There will be a written examination and interview for the selection of suitable candidates. No TA/DA is admissible for attending the examination/ Interview.

12. Admission at all the stages of examination for which candidates are admitted by the Commission viz: Main (written) Examination and Interview Test will be purely provisional and is subject to satisfying the prescribed eligibility conditions. If, on verification at any stage of the examination process, it is found that candidates do not fulfill any of the eligibility conditions, their candidature for the post will be rejected by the Commission without notice.

13. The Commission will not entertain any application on review or RTI/Correspondence till the entire process of recruitment is complete.
