2. SELECTION PROCEDURE:

- The selection procedure for the above post will be by the way of written test/skill test in concerned trade taking into consideration of job requirement for Accountant post.
- ii) All the tests will be conducted at Nagpur City only.

If required, selection will be depending upon nature of the post. The decision of the MECL will be final in this regard. The name of the shortlisted candidate will be displayed on MECL website www.mecl.gov.in under head "CAREER".

3. GENERAL INFORMATION AND INSTRUCTIONS:

- i. Only Indian national needs to apply.
- No any application registration fee for above special recruitment drive for persons with disabilities (PwD).
- iii. The cutoff date for reckoning educational qualification, experience and age etc. shall be the 31.05.2016 for submitting the online application through website.
- iv. Before submission of the online application, candidates are advised to carefully read the full advertisement for details of educational qualifications, age, experience and other eligibility criteria and ensure that he/she fulfills the eligibility criteria and other conditions mentioned in this advertisement for the post applied for.
- v. Shortlisting of candidates for calling for written test / skill test will be purely provisional subject to satisfying the prescribed eligibility conditions. Mere issue of call letter for the written test to the candidate will not imply that his/her candidature has been finally cleared by MECL. MECL will take up verification of eligibility conditions with reference to original documents at the time of selection procedure.

- vii. For the above post, candidates should possess Degree / Diploma from an Indian University / Institute/Board approved or recognized by Government /UGC/ AICTE/ appropriate statutory authority, as the case may be in their respective case.

5. RELAXATIONS AND CONCESSION:

i. Relaxation for Persons with Disabilities (PwD) (Degree of disability 40% or above) candidates:

For Persons with Disabilities (PWD), upper age limit is relaxable up to 10 years for General, 15 years for SC/ST and 13 years for OBC-NCL for above post.

Such candidate will be required to produce the requisite certificate, in the prescribed format of Government of India, from a competent authority indicating clearly the candidate's caste, the Act/Order under which the caste is recognized as SC/ST and the village/town the candidate is ordinarily a residence of at the time of written test / skill test, if Persons with Disabilities (PWD) candidate's will be required to produce medical certificate in the prescribed form issued by the Competent Medical Authorities for the purpose of employment.

OBC candidates belonging to 'Non-Creamy Layer'. Such candidates will be required to produce the requisite certificate, in the prescribed format of Government of India, from a Competent Authority issued in the <u>current financial year</u>, indicating clearly the candidate's caste, the Act/Order under which the caste is recognized as OBC (NCL) and the village/town the candidate is ordinarily a residence of, at the time of selection procedure, if called for.

OBC (Non-Creamy Layer) candidates must ensure that the name of their caste (including its spelling) as indicated in the certificate should be exactly the same as published in the lists, notified by the Central Government from time to time. A certificate containing any variation in the caste will not be accepted.

A declaration in the prescribed format by candidate seeking reservation as OBC (Non-Creamy Layer), that he/she does not belong to the creamy layer on the crucial date, in addition to the community certificate (OBC). The last date of receipt of on-line application will be treated as a crucial date for considering the Non-Creamy Layer in the current financial year.

The OBC candidates who belong to 'Creamy Layer' are not entitled to OBC concession and they have to indicate their category as 'General'.

ii. Relaxation for J&K Candidates:

Upper age limit is relaxable by 5 years for the candidates who had ordinarily been domiciled in the State of Jammu & Kashmir from 01.01.1980 to 31.12.1989.

iii. Relaxation for Ex-servicemen:

Age relaxation to ex-servicemen will be as per Government of India guidelines.

vi. Relaxation for internal candidates:

Relaxation in age, experience and qualification for internal candidates will be governed by the Recruitment Policy of the corporation. Maximum age is relaxable up to 20 (twenty) years to retrenched ex-contingent workmen of MECL for the post of Accountant.

6. HEALTH:

Appointment of candidates shall be subject to his/her being declared medically fit for the Company's service by Govt. Medical Officer/CMO.

7. Action against Applicants found guilty of Misconduct use of Unfair means:

Applicants are advised in their own interest that they should not furnish any particulars that are false, tampered with or fabricated and should not suppress any material information while submitting online application. 8. HOW TO APPLY:

The candidates are required to apply online. The relevant link will be made available from 20.06.2016 to 19.07.2016 under the head of "CAREER" of MECL website: www.mecl.gov.in. Applications received through any other mode will not be accepted. Before filling application online, candidate should keep ready scanned copy of passport size photograph and signature in JPG/JPEG format and caste certificate & PwD certificate in pdf format. Fill in the online form with all relevant details. Upload scanned copy of photograph and signature in JPG/JPEG format and caste and Pwd certificate. Candidates should ensure that the relevant details which name, date of birth, address and qualification etc. entered in the MECL online application should be correct. Candidates of SC/ST and OBC (NCL) category should be careful while filling up category option in the online application format as this will not be allowed to be changed at later date.

Before registering their applications on the MECL's website the candidate should possess the following:-

- (i) Valid e-mail ID and mobile number, which should <u>remain valid for at least one year</u> as any important intimation to the candidates shall be provided by MECL through E-mail. No change in email id will be allowed after filling online application. They are further advised to check their E-mail regularly for any communication from MECL in this regard.
- (ii) Personal details, educational qualification details, experience details and community details.
- (iii) Photograph must be recent passport size color picture. The photo should be in colour, against a light- coloured, preferably white, background. Look straight at the camera with a relaxed face. If the photo is taken on a sunny day, have the sun behind you, or place yourself in the shade, so that you are not squinting and there are no harsh shadows.

If you have to use flash, ensure there no "redeye" If you wear glasses make sure that there are no reflections and your eyes can be clearly seen. Caps, hats and dark glasses are not acceptable. Religious headwear is allowed but it must not cover your face. Dimensions 150 X 200 pixels (preferred). Size of image should be 50KB. Ensure that the size of the scanned Image is not more than 50KB. If the size of the file is more than 50KB, then adjust the settings of the scanner such as the DPI resolution during process of scanning.

(v) Signature image has to sign by the applicant in white paper with Black Ink pen. The signature must be signed only by the applicant and not by any other person. The applicant's signature obtained on the call letter and attendance sheet at the time of the examination should match the uploaded Signature. In case of mismatch, the applicant may be disqualified. The dimensions of signature must be 50 X100 pixels (preferred), ensure that the size of the scanned Image is not more than 20KB.

- (vii) If candidate belong to PwD category has to scan their PwD certificate in Pdf format & ensured that the size of scanned certificate not more than 350KB.
- Scanned photograph, signature resolution to a minimum of 200 dpi(dots per inch). Set Color (viii) or True Color, File Size as specified above. Crop the Image in the scanner to the edge of the photograph/signature. The image file should be JPG or JPEG format and document in pdf format. An example file name Is: imaged 01. jpg or image 01. jpeg Image dimensions can be checked by listing the folder files or moving the mouse over the file image icon. - Procedure for Uploading: There will be separate links for uploading Photograph, Signature, (ix) certificate and PwD certificate. Click on the respective link Photograph/Signature/ caste certificate/ PwD certificate". Browse & Select the location where the Scanned Photo/Signature file has been saved. Select the file by clicking on it. Click the "Upload" button. An online application which is incomplete in any respect much as without photograph and signature uploaded in the online application form will not be considered as valid.
